

PRESSING'S QUALITY AND ENVIRONMENTAL POLICY

The Management of PRESSING IMPRESSIÓ DIGITAL S.A., a company dedicated to comprehensive printing services on different substrates and finishes, defines in its management policy its commitment to quality and the environment. The Policy is based on the following aspects:

- **Satisfaction of interested parties** in our printing services, by offering high-quality and environmentally friendly work that meets their needs, all while optimizing response times.
- **Risk assessment and prevention** in order to minimize errors that could affect the service provided and to uphold our commitment to environmental protection and pollution prevention.
- **Compliance with health and safety standards** by implementing work procedures that ensure printing products are handled, stored, and transported safely to prevent physical harm or exposure to hazardous substances, and by using materials and products free of toxic or harmful substances, and inks or additives that meet environmental safety standards.
- **Continual improvement** of processes, the service provided, and the environmental impact of our activities, with the involvement of the people who work in the organization and our suppliers. Establishment of long-term objectives and goals with periodic reviews to identify areas for improvement, as well as opportunities for innovation and reduction of environmental impact.
- **Optimization of energy consumption** through the use of energy-efficient equipment and efficient usage practices.
- **Reduction of greenhouse gas emissions** and other atmospheric pollutants associated with our operations, by promoting the use of renewable energy, implementing solar panels, a more sustainable transport fleet, prioritizing non-polluting inks, and responsible waste management.
- **Sustainable water management** by monitoring its consumption (mainly domestic), implementing measures to reduce it with specific objectives, identifying opportunities for improvement, and promoting sustainable practices such as installing water-saving devices or the immediate repair of leaks.
- **Responsible management of hazardous and non-hazardous waste** in accordance with environmental regulations through proper segregation and disposal of waste, prioritizing its recycling and reuse, and adopting practices that minimize its generation, such as the efficient use of paper and the reduction of unnecessary packaging.
- **Sustainable management of raw materials** by prioritizing the use of non-polluting inks with a lower environmental impact and paper from managed forests

where ecological and social values and responsible forest management are respected, generally promoting the use of more environmentally friendly products and the reduction of raw material use.

- **Responsible and safe use of chemical products** in all printing processes. Training of personnel in their handling and storage and in the necessary safety measures to prevent incidents. Optimization of processes by encouraging innovation with more sustainable products and the reduction of their consumption. Printing techniques that minimize the use of resources and environmental impact.
- **Promotion of sustainable consumption** by offering a range of products that use recyclable, recycled materials (such as recycled or FSC/PEFC certified paper) and are produced with printing techniques that minimize the use of resources and environmental impact. Promoting collaboration with sustainable suppliers as well as the design of products that are easier to recycle or reuse at the end of their life, facilitating disassembly and separation of materials and reducing non-recyclable components.
- **Education and awareness:** Raising staff awareness of the importance of sustainability by providing tools and knowledge to implement sustainable practices in their daily work. Training programs on the proper use of materials and equipment, safe work practices, handling of chemical substances, and use of machinery. Training on how to properly separate and classify waste. Promoting employee participation in environmental improvement initiatives.
- **Compliance with all legal and regulatory requirements** that affect our activities and services in the different areas of management and with all applicable environmental regulations regarding printing and waste management. Actively seeking opportunities for improvement beyond the minimum legal requirements.
